Motion made, seconded and passed to approve the Pre-Conference Board Meeting Minutes. Motion made, seconded and passed to approve the Post-Conference Board Meeting Minutes.

2011 Conference Report: Conference Report emailed to the Board. The date of the Conference has changed and now will be April 15th and 16th, 2011. The Hotel will be Pocatello Holiday Inn. Wendy Mickelson will be in charge of all speakers and AV set ups and CEU applications to ASRT. Richelle Heldwein will be in charge of registration, food, budget, entertainment, donation collections and door prizes. A save the date card will be sent in early January. Registration forms will be included on the web site. Consider having a reduced registration fee to promote attendance. Motion made, seconded and passed to offset the registration fee cost of ISRT members 40% so that members will be paying a lot less than nonmembers for the Conference.

> Discussed the request for ISRT support from Leslie Kendrick, MS, RT(R)(CT)(MR) regarding the Exhibit Contest. BSU would like to propose a change to the ISRT poster board competition specifications. They are requesting that the ISRT advance the poster board competition standards to be laminated scientific posters. Motion made, seconded, and passed that the ISRT will support the request and also will modify the Exhibit Regulations to include "and/or" for doing the Exhibit this way so that those doing that kind of Exhibit can also be included in the Contest. Currently, the regulations state that the exhibits shall not exceed 36" x 48". According to the letter received from Leslie Kendrick. the laminated posters she is proposing are also 36" x 48". Possibly in the future, we can have this type of research exhibit done as a separate category.

The idea was discussed of having a "Fun Bus" to Pocatello. Mike will research this and let the Board know.

Discussed the fact that SEISRT has not dissolved yet. They need to either dissolve and send their money to ISRT which could be designated for the Conference. Or establish their own EIN, etc as stated under the IRS guidelines. Rikki will contact the SEISRT people and discuss it with them.

September 25, 2010

President's Report: The business cards are done and will be distributed to the Board Members.

The current Chairman (David) and the current President (Rikki) will be attending the ASRT Conference in 2011.

President Elect's Report: Working on another Proclamation for Rad Tech Week. Discussed media and promoting our profession.
